acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and
release unto the said L. L. Knighton, his heirs and assigns forever:

ALL that certain piece, parcel or lot of land situate, lying and being in
the County of Greenville, State of South Carolina, and being known and
designated as the southern one-half of Lot 1, Block 2 as shown on the
County Block Book Map 318 and having the following metes and bounds, to wit:
BEGINNING at an I.P. on the eastern side of Highland Avenue at joint corner
of Lot 4 of the East View Heights Subdivision, which subdivision map is
recorded in the RMC Office for Greenville County in Plat Book WW at Page
