ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, and being shown as a portion of Hope Street on a plat of the Property of Lloyd Gilstrap which is recorded in Plat Book 00 at Page 67 in the RMC Office for Greenville County, S. C., and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwestern corner of Hope Street at its intersection with North Harbor Drive; thence N. 51-50 E. 25 feet to a point in the center of a street formerly known as Hope Street; thence with the center of Hope Street, N. 38-30 W. 137.72 feet to a point in the center of Old Farris Bridge Road; thence with the center of Old Farris Bridge Road, S. 82-30 W. 29.01 feet to a nail and cap; thence with the common line of Lot 26, S. 38-30 E. 152.45 feet to the beginning corner.

For authority to execute this deed reference is made to the Minutes of the County Council Meeting on August 15, 1978, whereby the Grantee was given permission to close Hope Street and the above-described property is a portion of said Hope Street.
