I KNOW ALL MEN BY THESE PRESENTS, that I, Lloyd D. Auten

in consideration of One and NO/100ths (\$1.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto McDonald's Corporation, its successors and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville near Woodruff Road, on the northwestern side of Power Drive consisting of a strip approximately 5 feet wide and approximately 204.17 feet long connecting Power Drive and passing within the southwestern side of a 25' road and crossing a 50' road and connecting to property owned by McDonald's Corporation; said strip identified as a water line parcel and being shown on a plat entitled Topographical Map for McDonald's Corporation dated April, 1978 by Dalton & Neves Co., Engineers, and having according to said plat the following metes and bounds to-wit:

Beginning at a point on the northwestern side of Power Drive and running thence N 25-37 W 142.79 feet within the southwestern side of a 25' road; thence turning and running across a 50' non-exclusive perpetual easement (road) N 59-29 W 61.0 feet to an iron pin at the northeastern edge of property of McDonald's Corporation; thence with said McDonald's Corporation property S 64-23 W 6.11 feet to a point; thence through the 50' non-exclusive perpetual easement (road) S 59-29 E 62.83 to an iron pin at the rear of property of Gulf Oil Company; thence along the northeastern edge of Gulf Oil Company property and within a 25' road S 25-37 E 141.34 feet to an iron pin on the northwestern edge of Power Drive; thence with the edge of said drive N 64-23 E 5 feet to a point, the beginning corner.
