
All that certain parcel or lot of land, situate, lying and being in Greenville County, State of South Carolina, Oneal Township, about two miles North of the City of Greer, 499.4 feet North of Miller Road, being shown as Lot No. 9 on plat of Property of M. M. Bryant, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book CCC at Page 207, and having, according to said plat, the following metes and bounds:

Beginning at an iron pin on the southern edge of Malinda Drive and running thence S 24-16 W 200 feet to an iron pin; thence N 61-20 W 100 feet to an iron pin; thence N 24-16 E 200 feet to an iron pin on southern edge of said street; thence therewith S 61-20 E 100 feet to the point of beginning.

As a part of the consideration this property is subject to the following restrictions which shall run with the land and shall be effective for a period of 20 years from January 23, 1963. (1) This property shall be used for residential purposes only; (2) No livestock or other animals shall be kept on the premises, except not more than two dogs and two cats may be kept as pets; (3) No obnoxious or offensive activity shall be engaged in which may be or may become an annoyance or nuisance to the neighborhood.
