EASEMENT

FOR AND IN CONSIDERATION of the sum of \$1.00 to the undersigned in hand paid by the City of Greenville, S. C., the receipt whereof being hereby acknowledged, (I) (we) hereby grant unto said City of Greenville, a right-of-way or easement along, over or under (my) (our) property for the purpose of:

To install and maintain a drainage system and a temporary right of access to fill, slope, grade, and seed the remaining portion of the existing ravine.

Together with the right of ingress and egress for the purpose of inspecting and maintaining the same.

Said easement is described as follows:

All that piece, parcel or lot of land lying and being in the City of Greenville County and State aforesaid and being a portion of the property known and designated as Block Book No. 91.2-5-54 as shown on plat prepared by the City of Greenville and entitled "Pearl Street Storm Drainage," recorded in the RMC Office and having the following metes and bounds to wit:

Beginning at a point which is 44 feet north from the southwest corner of Lot 91.2-5-54 and running thence in a northerly direction 20 feet, more or less, to a point; thence westerly 64 feet, more or less, to a point on the western property line of Lot 54; thence in a southerly direction 20 feet, more or less, to a point which is 29 feet from the southwest corner of Lot 54; thence in an easterly direction 62 feet, more or less, to the point of beginning.

Said easement contains approximately 1,260 square feet.
