Heights, County of Greenville, State of South Carolina, including approximately
222 feet, more or less of 6" C.I. Pipe; approximately 4,820 feet, more or less,
of 2" Galv. Pipe; 330 feet, more or less, of 1 1/2" Galv. Pipe and 28, 5/8"
Water Meters and Boxes as shown on drawing entitled Rockview Heights Water
