In consideration of Five Thousand Three Hundred and NO/100 (\$5,300.00)----- Dollars the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JACOB SAMMONS, his heirs and assigns forever:

ALL that certain piece, parcel or lot of land, located, lying and being in the County of Greenville, State of South Carolina, on the southwestern side of Hampton Avenue Extension and being known and designated as Lot 4 on plat entitled "Property of Jacob Sammons", dated March 22, 1979, prepared by Jones Engineering Service, recorded in the Greenville County R.M.C. Office in Plat Book 713 at Page 82, and having, according to said survey, the following metes and bounds to-wit:

BEGINNING at a point on the southwestern side of the right-of-way of Hampton Avenue Extension at the joint front corner of Lots 3 and 4 and running thence along said right-of-way S. 75-57 E., 50.87 feet to a point at the joint front corner of Lots 4 and 5 (said point being 137.4 feet westerly from Kelly Avenue); thence along the joint line of Lots 4 and 5 S. 17-57 W., 150 feet to an old iron pin; thence N. 75-57 W., 50.87 feet to a point at the joint rear corner of Lots 3 and 4; thence along the joint line of said lots N. 17-57 E., 150 feet to a point on the southwestern side of the right-of-way of Hampton Avenue Extension, the point and place of beginning.
