the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto ELOISE T. STAMBAUGH, subject to life estate interest hereinafter reserved.

ALL that certain piece, parcel or tract of land situate on the northern side of Trammell Road in the County of Greenville, State of South Carolina being shown as a tract containing 6.66 acres more or less on a plat of the Property of Eva Trammell, dated March 15, 1979, prepared by C. O. Riddle, Surveyor, recorded in Plat Book 6-V at page 65 in the RMC Office for Greenville County and having according to said plat the following metes and bounds, to-wit:
