All that lot of land in Greenville Township, Greenville County, State of South Carolina, on the eastern side of Fairview Avenue, in the City of Greenville, being the southern 55 feet of Lot No. 36 and the northern 35 feet of Lot 35, as shown on Plat of Alta Vista made by R.
