ALL that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 2.1 acres, situate on the southwesterly side of U. S. Highway 276, and having, according to a survey prepared by W. R. Williams, Jr., R.L.S., dated July 1, 1970, and recorded in the R.H.C. Office for Greenville County in Plat Book 4-H at Page 57, the following metes and bounds, to-wit: -376 - 513.2 - 1 - 28.1

BEGINNING at an iron pin on the southwesterly side of U. S. Highway 276 in line of property now or formerly of C. A. Henson, Jr., and running thence with U. S.
