In consideration of the sum of \$100.00, hereinafter set out and other good and valuable consideration, the adequacy and receipt of which is hereby acknowledged from the Southern Bell Telephone and Telegraph Company, the undersigned, owner(s) of the premises described below, do hereby grant to the Southern Bell Telephone and Telegraph Company, its licensees, agents, successors, assigns, and allies and associated companies, a right of way easement to construct, operate, maintain, add or remove such lines or systems of communications or related services as the grantee may require, consisting of:

- 121 buried cables and wires, cable terminals, markers, splicing boxes and pedestals;
- 131 conduits, manholes, carriers, underground cables and wires;

upon over and under a strip of land 2 feet wide across the following lands in GREENVILLE County, State of SOUTH CAROLINA, generally described as follows: **THAT TRACT OF LAND AS SHOWN AND IDENTIFIED ON LICHTER GREENVILLE TAX MAP NUMBER 205 AS LOT NUMBER 38 BOUNDED ON THE NORTH BY MOUNT VISTA AVENUE AND ON THE SOUTH BY BYRD BOULEVARD AND ON THE EAST BY Lot NUMBER 37. SEE SKETCH ON BACK OF THIS EASEMENT FOR TELEPHONE PLANT APPLYING TO THIS EASEMENT.**

and, to the fullest extent the undersigned has the power to grant, if at all, over, along and under the roads, streets or highways adjoining or through said property.

The following rights are also granted: to enter upon said easement to obtain access to other areas or easements within the boundaries of the property; to clear the land and keep it cleared of all trees, undergrowth or other obstructions within the easement areas; to trim and cut and keep trimmed and cut all trees, brush, felling or dangerous trees or limbs outside of the easement areas which might interfere with or妨害 the lines or systems of communications.

The receipt of One hundred and 10.00 dollars (\$100.00) is hereby acknowledged by the undersigned.

To have and to hold the above granted easement unto Southern Bell Telephone and Telegraph Company, its successors and assigns forever.
