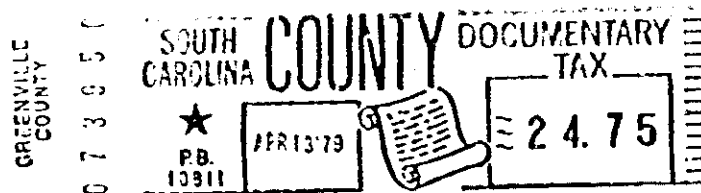
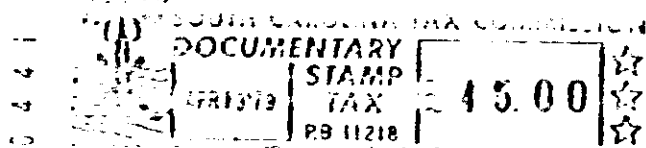
In consideration of Twenty Two Thousand, Five Hundred and No/100-----Dollars,
