to us in hand paid at and before the sealing of these presents by WILLIAM F. RAPOLE and wife, SHIRLEY RAPOLE,

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these

presents do grant, bargain, sell and release unto the said WILLIAM F. RAPOLE and SHIRLEY RAPOLE, their heirs and assigns, an undivided one-half interest in and to all that piece, parcel or lot of land in Glassy Mountain Township, Greenville County, State of South Carolina, and Campobello Township, Spartanburg County, State of South Carolina,

Adjoining the lands of Jerry Bradshaw, Milton E. Prevost and Jean W. Prevost, lands now or formerly belonging to C. B. Kuykendall, the right of way of the Southern Railway System and others, and more particularly described by metes and bounds as follows:
