and release unto Donnie W. Miller and Miriam R. Miller, their heirs and assigns forever;

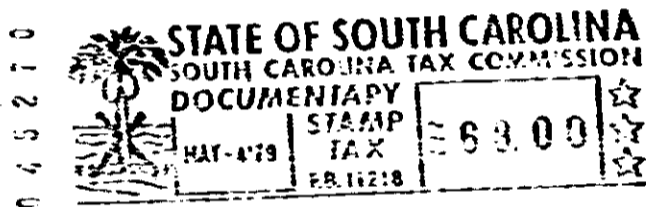
