Wilson Dillard and his heirs and assigns forever,

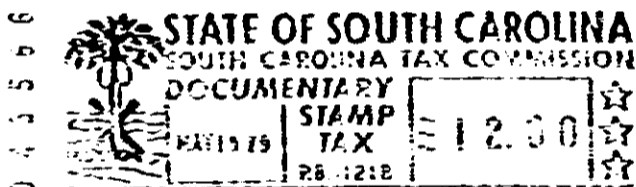
