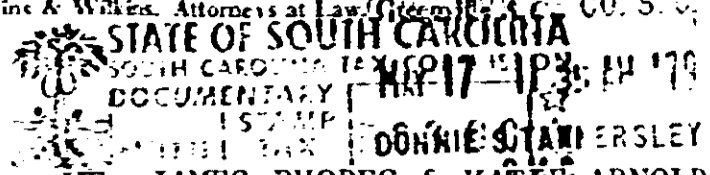

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto **ELIZABETH S. CARPER & SHIRLEY R. BENNETT,** their heirs and assigns:

All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, and being more particularly described as lot No. 36 as shown on plat entitled "Subdivision for Abney Mills, Poinsett Plant, Greenville, South Carolina", by Pickell & Pickell, Engineers, Greenville, South Carolina, March 5, 1959, and recorded in the RMC Office for Greenville County in plat book QQ pages 51 and 57, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on Owens Street and running thence with Owens Street N. 37-16 W. 68 feet; thence N. 50-51 E. 101 feet to an iron pin; thence S. 40-44 E. 68 feet to an iron pin; thence S. 50-51 W. 105 feet to the point of beginning, said lot being also known as 14 Owens Street.

This is the same lot conveyed to grantors by Martha Inez Taylor by deed dated June 19, 1969 recorded June 20, 1969 in deed vol. 870 page 362 of the RMC Office for Greenville County, S.
