of being hereby acknowledged, (I) (we) hereby grant unto said City of  
Greenville, a right-of-way or easement along, over or under (my) (our)  
property for the purpose of:

To install and maintain a storm drainage system.

Together with the right of ingress and egress for the purpose of inspect-  
ing and maintaining the same.

Said easement is described as follows:

All that piece, parcel or lot of land lying and being in the City of  
Greenville County and State aforesaid and being a portion of the  
property known and designated as Block Book No. 95-10-30 as shown  
on plat prepared by the City of Greenville and entitled "Storm  
Drain Easement," recorded in the RMC Office and having the  
following metes and bounds to wit:

Beginning at the northwestern corner of Lot 95-10-30 and running  
thence S. 83-35 E. 109 feet, more or less, to a point on Dean Street;  
thence along Dean Street S. 19-30 W. 5 feet, more or less, to a  
point; thence N. 83-35 W. 109 feet, more or less, to a point; thence  
N. 19-30 E. 5 feet, more or less, to the point of beginning.

Said easement contains approximately 545 square feet.
