release unto ARTISTIC BUILDERS, INC, its successors and assigns forever;

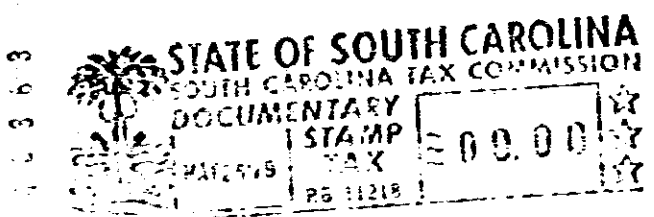
ALL that certain piece, parcel or lot of land in the Town of Simpsonville,
