Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and
- 3. The property referred to by this agreement is described as follows: All that certain piece, parcel, or lot of land in the City of Simpsonville, County of Greenville, State of S.C., on Brookmere Rd., being shown and designated as Lot No. 44, on plat of Section No. IV, Bellingham, recorded in the RMC Office for Greenville County, S.C. in Plat Book "5P", at Page 48, and having, according to said plat, the following metes and bounds, to wit: Beginning at an iron pin on the westerly side of Brookmere Rd., joint front corner of Lots Nos. 144 and 45, and running thence with the joint lines of said lots, N. 82-48 W. 150 feet to an iron pin; thence S.7-12 W. 80 feet to an iron pin, joint rear corner of Lots Nos. 43 and 44; the running thence with the joint lines of said lots, S.62-48 E. 150 feet to an iron pin on the westerly side of Brookmere Rd.; thence with the westerly side of Brookmere Rd. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
