The expression or designation "Grantor" wherever used herein shall be understood to include the Mortgagee, it any there be:

- 2. The right-of-way is to and does convey to the Grantee, its successors and assigns the following: The right and privilege of entering the aforesaid strip of land, and to construct, maintain and operate within the limits of same, pipe lines, manholes, and any other adjuncts deemed by the Grantee to be necessary for the purpose of conveying sanitary sewage and industive wastes, and to make such relocations, changes, renewals, substitutions, replacements and additions of or to the same from time to time as said Grantee may deem desirable; the right at all times to cut away and keep clear of said pipe lines any and all vegetation that might, in the opinion of the Grantee, endanger or injure the pipe lines or their appurtenances, or interfere with their proper operation or maintenance; the right of ingress to and egress from said strip of land across the land referred to above for the purpose of exercising the rights herein granted; provided that the failure of the Grantee to exercise any of the rights herein granted shall not be construed as a waiver or abandonment of the right thereafter at any time and from time to time to exercise any or all of same. No building shall be erected over said sewer pipe line nor so close thereto as to impose any load thereon.

It is turther agreed: That in the event a building or other structure should be erected contiguous to said sewer pipe line, no claim for damages shall be made by the Grantor, makeus or assigns, an account of any damage that might occur to such structure, building or contents thereof due to the operation or maintenance, as negligeness of operation or maintenance, of said pipe lines or their appurtenances, or any accident of mishap that it ight occur therein or thereto.
  - 5. All other or special terms and conditions of this rigit of way are as belows.

6. The payment and privileges those specified are hereby accepted in full settlement of all claims and damages of what ever nature for said right of way.

7. In the event plans for said sewer lines are concelled or altered and this right of way is not needed, then same may be cancelled and no money shall be due the Grantors. The payment of the consideration for this right of way shall be made before construction commences.
