the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Harold R. Massengale and Geneva P. Massengale, their heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being in Highland Township, Greenville County State of South Carolina, on the south side of Pack Mountain, east of and adjoining the Slatton Road and having the following metes and bounds: to-wit:

BEGINNING on a stone on the east bank of said Slatton Road, also Luke Slatton's corner and running eastward with Luke Slatton's line 821 feet to a stake near the Cleary Spring Branch, also Milas E. Bomar's line, 665 feet, more or less, to a stake near a small sweet gum, also Milas E. Bomar and W. A.
