CORRECTIVE DEED

KNOW ALL MEN BY THESE PRESENTS, that JOHN J. SANDERSLEY
SMB CORPORATION

A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at
Greenville, State of South Carolina, in consideration of ONE AND NO/100-----
-----(\$1.00) and correction of deed----- Dollars,

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and
release unto WAFFLE HOUSE, INC., its successors and assigns, forever:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of
South Carolina, County of Greenville on the Eastern side of White Horse Road and being
shown on a Plat prepared by Piedmont Engineers and Architects, which Plat is recorded
in the RMC Office for Greenville County in Plat Book 6-U at Page 89 and having, according
to said Plat, metes and bounds, to-wit:

BEGINNING at an iron pin on White Horse Road at the joint front corner of property herein
and property now or formerly of Hattie L. Gravette, et al and said iron pin being located
246 feet Northwest of the intersection of White Horse Road and Jacobs Road; running thence
along White Horse Road N. 32-16 W. 90 feet to an iron pin; thence turning and running
N. 61-15 E. 200 feet to an iron pin; thence turning and running S. 32-16 E. 90 feet to an
iron pin in the joint line of property herein and property of Hattie L. Gravette and
others; thence turning and running along the joint line of said property, S. 61-15 W.
200 feet to an iron pin, the point of beginning.

This conveyance is made subject to easements, restrictions and rights of way of record,
including that certain right of way to Gantt Sewer, Police and Fire District as recorded
in Deed Book 901 at Page 529 in the RMC Office for Greenville County and that certain
right of way to said District as recorded in Deed Book 908 at Page 531 and also subject
to a 60 foot right of way to the South Carolina Highway Department, extending from the
center line of White Horse Road.
