ALL water lines, mains, valves and appurtenances installed and located in, under or along Gilderbrook Road, Cobblestone Road, Cobblestone Court, Gilderbrook Road and Lynchester Road, County of Greenville, State of South Carolina, including approximately 2,560 feet of 8" D.I. Pipe; 28 feet of 6" D.I. Pipe; 220 feet of 2" Galv. Pipe; 3 - 8" Valves; 2 - 6" Valves; 2 - 2" Valves and 2 Fire Hydrants and is shown on a drawing entitled "Brookfield West, Section I, The Vista Company, Inc., to Commissioners of Public Works of the City of Greenville, S.C.", dated June 29, 1979, attached hereto and made a part of this conveyance.
