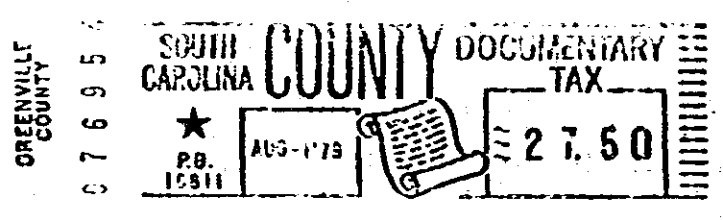
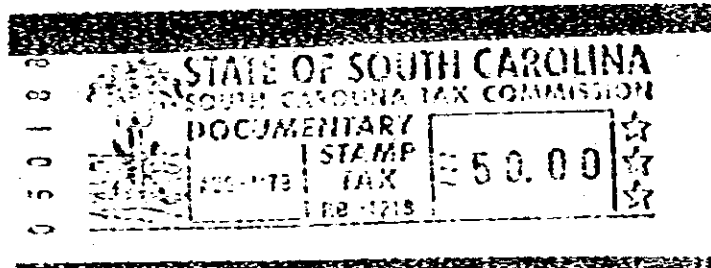

Rollins, hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said GranteeS their heirs and assigns forever

ALL that piece, parcel or lot of land situate, lying and being near Greenville in Greenville County, South Carolina adjacent to Old Buncombe Road, containing 0.48 acres, and having according to "Survey for Inez P. Burns" the following metes and bounds, to-wit: 451-1-26.1 Also PTOF 451-1-26.1

BEGINNING at an iron pin at the edge of the right-of-way of Old Buncombe Road and running thence N. 76-36 E. 209.7 feet to an iron pin at corner of other property of Inez P. Burns; thence turning and running along said property of Inez P. Burns S. 2-03 W. 108.1 feet to an iron pin; thence turning and running S. 76-35 W. 193.7 feet to an old iron pin at the edge of the right-of-way of Old Buncombe Road; thence turning and running N. 6-25 W. 105 feet along the edge of the right-of-way of Old Buncombe Road to an iron pin, the point of beginning.
