ALL that certain piece, parcel, or lot of land, situate, lying and being in  
Paris Mountain Township, Greenville County, South Carolina, on waters of  
Saluda River, adjoining lands of A. I. Thompson, C. B. Wynn and Farr property,  
containing nine and one-half (9.5) acres, as shown by survey of W. A. Hester  
dated February 23, 1946, and having the following metes and bounds:

BEGINNING at an iron pin, corner of land of Mrs. Farr, and running thence
