in consideration of Seven Thousand Five Hundred and No/100-----(\$7,500.00)-----Dollars,

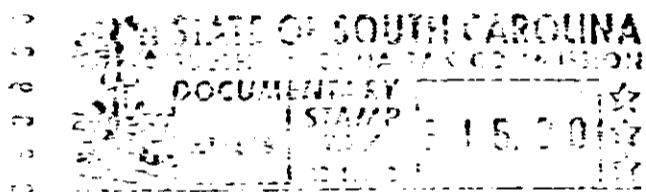
