the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto THE COMMISSIONERS OF PUBLIC WORKS OF THE CITY OF GREENVILLE, S.C., their successors and assigns:

The Grantor does hereby grant, bargain, sell and release unto the Grantee the right, privilege and easement to enter upon and exit from the property of the Grantor located along Holly Woods Lane in Holly Woods, Section 1, in Greenville County, South Carolina, in and through said property of the Grantor as shown on the drawing entitled "Holly Woods Sec. 1 James P. McNamara and Joe W. Hiller to Commissioners of Public Works", dated January 2, 1979, attached hereto and made a part hereof, for the purpose of reading, operating, maintaining, replacing and adding to the water meters and other appurtenances thereto located on the said property of the Grantor.

It being understood that the water mains located in and serving Holly Woods, Section 1, and being on the property of the Grantor, shall be and do remain the property of the Grantor and Grantor shall be fully responsible for the maintenance thereof.

The within water lines were conveyed to the Grantor herein by deed of The Commissioners of Public Works of the City of Greenville, S. C. recorded in the RMC Office for Greenville County in Deed Book 1113 at page 431 to be recorded herewith.
