release unto Annie Laurie Dugan, her heirs and assigns forever:

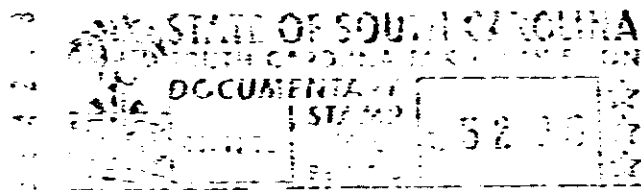
ALL that certain piece, parcel or unit, situate, lying and being in the State of
