the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto RALPH HOWARD, JR., his heirs and assigns forever:

ALL my right, title and interest, the same being an undivided one-third (1/3) interest, in and to the following described real estate:

ALL that certain piece, parcel or lot of land with the improvements thereon situate on the western side of Webster Street in the County of Greenville, State of South Carolina, known and designated as Lot No. 7, Block H, of the Subdivision known as S. Slater & Sons, Inc., according to a plat of record in the R.M.C. Office for Greenville County in Plat Book K at Pages 63, 64 and 65, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Webster Street at the joint corner of Lots Nos. 7 and 8, Block H, and running thence S. 82-41 W. 123.85 feet to an iron pin; thence S. 7-24 E. 70 feet to an iron pin at the joint rear corner of Lots Nos. 6 and 7; thence N. 82-41 E. 123.78 feet to an iron pin on the west side of Webster Street; thence with Webster Street, N. 7-19 W. 70 feet to the beginning corner.
