ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being on the West side of Augusta Court in the City of Greenville, County of Greenville, State of South Carolina and being shown and designated as Lot No. 34, Block C, on plat of AUGUSTA COURT made by R.
