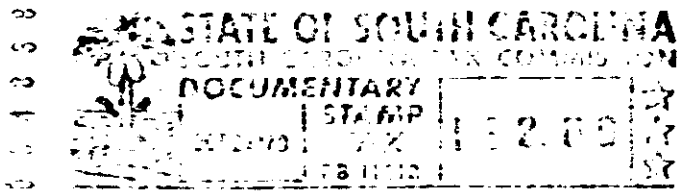
in consideration of Sixty-five Thousand Nine Hundred Fifty & no/100 (\$65,950.00) Dollars,
