KNOW ALL MEN BY THESE PRESENTS, that Joe W. Hiller

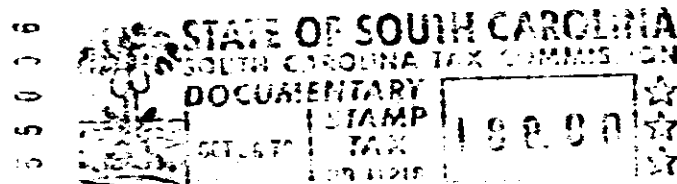
in consideration of Twenty Four Thousand & 00/100---- (\$24,000.00) and exchange of property Dollars,
