THOMAS F. METZ AND TONI A. METZ, their heirs and assigns forever:

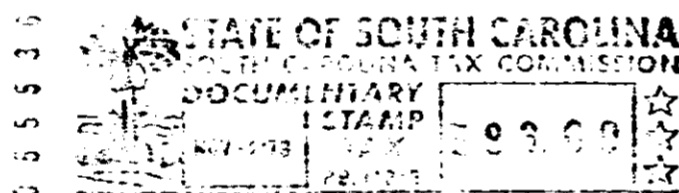
ALL that piece, parcel or lot of land situate, lying and being on the northern side of Lee East Court, near the City of Greenville, in the County of Greenville, State of South Carolina, and known and designated as Lot No. 9 of a subdivision known as Lee East, plat of which is recorded in the RMC Office for Greenville County in Plat Book 6H, at page 40, and according to said plat, has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Lee East Court, joint front corner of Lots Nos. 8 and 9, and running thence with the joint line of said lots, N. 41-16 W., 154.63 feet to an iron pin; running thence S. 87-59 E. 150 feet to an iron pin at the joint rear corner of Lots 9 and 10; running thence with the joint line of said lots, S. 8-59 W., 105.6 feet to an iron pin on the northern side of Lee East Court; running thence with the northern side of said Court, which line is curved, the chord of which is S. 78-03 W., 32 feet to an iron pin, point of beginning.
