3. Hereby assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise, and howsoever for or on account of that certain real property situated in the County of Greenville _______, State of South Carolina, described as follows:

All that lot of land in the county of Greenville, state of South Carolina, being known and designated as Lot No. 38 on plat of OAKFERN, Section 2, recorded in the RMC Office for Greenville County in plat book 6 H page 53, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of Oakfern Court, the joint corner of Lots 38 & 39 and running thence with the joint line of said lots N. 64-39 E. 163.8 feet to an iron pin; thence turning S. 6-58 E. 162.79 feet to an iron pin joint rear corner of lots 37 & 38; thence with the joint line of said lots S. 83-39 W. 156.38 feet to an iron pin on the east side of Oakfern Court; thence with the eastern side of said street N. 12-24 W. 66.98 feet to an iron pin; thence continuing N. 2-39 E. 43.36 feet to an iron pin, the point of beginning.

That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.

5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.

6. Upon payment of all indebtedness of the undersigned to Eank this agreement shall be and become void and of no effect, and until them it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continues force of this agreement and any parton may and it became authorized to really thereon.
