the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto  
ROBERT E. STEADMAN and BEVERLY J. STEADMAN, their Heirs and Assigns, forever:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville and being known and designated as Property of Sybil M. Stewart and Property of Sandra Jo Lynn Cisson, located on the eastern side of Lorena Drive, and having the following metes and bounds, to wit:

BEGINNING at a power pole on the eastern side of Lorena Drive at the front corner of Lot 12 of Lorena Park and running thence N 82-06 E 105.4 feet to an iron pin; thence turning and running S 12-18 W 19.5 feet to a new iron pin; thence turning and running N 87-24 W 100.4 feet to a power pole, the point of beginning.

Reference is hereby made to plat entitled, "Lorena Park, Lot 12, Property of Robert E. Steadman and Beverly J. Steadman", prepared by Freeland & Associates, dated April 27, 1979 and recorded in the RMC Office for Greenville County in Plat Book 7K, Page 89.

This deed is executed for the purpose of correcting the records insofar as deed recorded in Deed Book 1115 at page 218 is concerned. This deed, recorded on November 8, 1979, was executed by Sybil M. Stewart only. A portion of the within described property is owned by Sybil M. Stewart and a portion is owned by Sandra Jo Lynn Cisson.

Being a portion of the property conveyed to Sybil M. Stewart by deed of L. W. Owens, recorded in the RMC Office for Greenville County on October 22, 1949 in Deed Book 396, Page 51, and being a portion of the property conveyed to Sandra Jo Lynn Stewart (now Sandra Jo Lynn Cisson) by deed of Sybil M. Stewart recorded in the RMC Office for Greenville County in Deed Book 591, Page 159 on January 17, 1958.
