- 5. No noxious or offensive trade such as but not limited to junkyards, sale of alcoholic beverages shall be carried on upon this tract, nor shall anything be done thereon which may be or become an annoyance or nuisance to the neighborhood.
- 6. No vehicle which does not have a current license plate on it may remain on the premises for more than 30 days.
- 7. No trailer, mobile home, shack, barn, or other outbuilding erected on the lots shall at anytime be used as a residence, temporarily or permanently, nor shall any residence of a temporary nature be permitted.
- 8. No signboard shall be displayed on the property except "For Sale" and "For Rent" which sign shall not be more than two by three feet in size.
- 9. These covenants and restrictions shall continue in full force and effect until December 31, 1989.
