the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto John Thomas James, Sr. and Judy Taylor James, their heirs and assigns, forever:

All that piece, parcel and lot of land located on the north side of Holcombe Road, approximately 508 feet from the Fork Shoals Road, Greenville County, State of South Carolina, and further shown on a plat prepared by Webb Surveying and Mapping Co., dated December, 1979, as property of John T. James and Judy T. James, consisting of 0.574 acres, and having according to the said plat the following metes and bounds, to-wit:
