and release unto Jess W. Franklin and Julia B. Franklin, their heirs and assigns, forever;

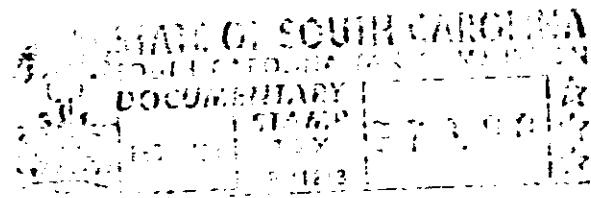
