All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and known and designated as Lot No. 16 and a portion of No. 15 in a subdivision known as McCain Heights and having, according to plat of same recorded in Plat Book J, page 59, the following metes and bounds, to-wit:
