REAL PROPERTY AGREMENTR

The affidavit of any officer of department manager of Association showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and compluing force of this agreement and any person play and is hereby authorized to rely thereon.
