KNOW ALL MEN BY THESE PRESENTS, that I, William T. Bishop

in consideration of ONE DOLLAR (\$1.00) LOVE AND AFFECTION ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Virgie L. Bishop, her heirs and assigns: A one-half (1/2) undivided interest in and to:

All that piece, parcel or lot of land in the Chick Springs Township, Greenville County, State of South Carolina lying between land of Grace E. Greer, and lands of William T. Bishop and containing one and 88/100 acres, more or less and having the following metes and bounds, to wit:

BEGINNING at an iron pin corner between the lands of Grace E. Greer and William T. Bishop and running thence S. 40-19 W. 130 feet to an iron pin; thence S. 27-16 E. 1372 feet to an iron pin, corner lands of Grace E. Greer and William T. Bishop and Lincoln School tract; thence along old line between land of Grace E. Greer and William T. Bishop N. 22-12 W. 1424 feet to the beginning corner, and having three sides.

This being the same property conveyed to William T. Bishop by Grace E. Greer, by deed dated January 18, 1960 and being recorded in the R. M. C. Office for Greenville County, S. C. at Book 642 and at page 406.
