and release unto Wilhelmina G. Duck, her heirs and assigns, forever:

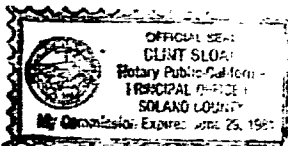
All that certain piece, parcel or lot of land situate on the southern side of Talley
