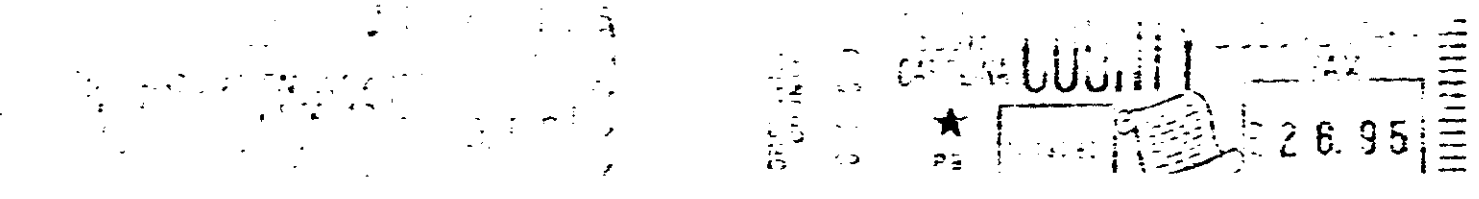
BEGINNING at an iron pin on the southern side of Plantation Drive at the joint front corner of Lot 29 and Lot 30 and running thence with Lot 29 S 18-11 W 150.26 feet to an iron pin; thence N 85-48 W 92.85 feet to an iron pin at the joint rear corner of Lot 30 and Lot 31; thence with Lot 31 N 13-39 E 156.14 feet to an iron pin on Plantation Drive; thence with said drive S 88-01 E 9 feet to an iron pin; thence still with said drive S 80-33 E 95 feet to the point of beginning.

This is a portion of the property conveyed to the grantor by deed of Holly Tree Plantation, a Limited Partnership, recorded on September 7, 1978 in deed Book 1086 at page 935 in the RMC Office for Greenville County.

As a part of the consideration the grantees assume and agree to pay the balance due on a mortgage to Fidelity Federal Savings & Loan Assn., recorded in Mortgage Book 1479 at page 820 in the RMC Office for Greenville County, the present balance being \$67,102.21.
