1/4 of my undivided 1/3 interest (or an undivided 1/12 interest) in:

ALL that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, near the City of Mauldin, on the northwestern side of Balcombe Blvd., containing approximately 3.2 acres, and being shown and designated on a compiled plat of Property of Lucetta M. Clifton, Jack Clifton and Dorothy M. Clifton, prepared by Freeland & Associates, dated 3-10-80 and recorded in the RMC Office for Greenville County in Plat Book 7-2, Page 57, and having, according to said plat, the following metes and bounds, to wit:
