

LOT 8 - BEGINNING at an iron pin on the Eastern Side of Timm Avenue and running thence in an Easterly direction 100 feet to a pin in the western boundary line of Lot 68; thence in a southerly direction 85 feet to a pin in the western line of Lot 67; thence in a westerly direction 100 feet to a pin on Timm Avenue; Thence in a northerly-direction 85 feet along Timm Avenue to a pin, the point of the beginning.
