QUIT-CLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, that Phyllis Blackston McCane

in consideration of One Thousand (\$1,000.00) Dollars,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto Robert D. Chandler, his heirs and assigns, my undivided interest in the following described property:

ALL that piece, parcel or lot of land in Dunklin Township, Greenville County, State of South Carolina lying West of Mountain Creek, waters of Saluda River, and containing 51.90 acres, more or less, according to a survey made by W. F. Lee in May 1919, and W. J. Riddle, a surveyor, made in July 1949, and have the following metes and bounds and courses and distances, as shown on said plat, to-wit:

BEGINNING at the center of a road and at the intersection of Mountain Creek and running thence along Mountain Creek as the line the following courses and distances: S. 24-30 E. 675 feet; thence S. 59-15 E. 834 feet; thence S. 49 E. 413 feet; thence S. 2-30 W. 135 feet to a stake in line of the Dewey Cothran property; thence along the line of the Cothran property N. 87-30 W. 847 feet to a stone in line of the Coker property; thence along the line of property of Coker, Epps, Sam Hipps and Smith, N. 46-30 W. 2409 feet to a stone in line of Cothran property; thence along the line of the Cothran property N. 7 W. 547.8 feet to a stone in line of the Pepper property; thence along the line of the Pepper property N. 83 E. 1299 feet to a stake in or near Mountain Creek and at the corner of tract No. 1 of this subdivision; thence running along Mountain Creek as the line the following courses and distances to the beginning point; S. 20 E. 340 feet; thence S. 4-30 W. 630 feet. This is the western portion of the Thos. O. Cooley estate property conveyed to N. E. Cooley and Mrs. Blanche P. Cooley by E. Inman, Master by deed dated October 9, 1948 and of record in the R.M.C. Office for Greenville County in Deed Book 361, Page 429. Blanche P. Cooley conveyed her undivided interest in the above land to N. E. Cooley by deed dated October 24, 1949 and recorded in the R.M.C. Office for Greenville County in Vol. 398, page 317.

The interest conveyed herein is all of the interest I have in the property acquired as a result of the death of my mother, Marguerite Chandler Blackston and grandmother, Martha R. Chandler.
