## REAL PROPERTY AGREEMENT

This agreement is made on the 29th day of APRIL

1980, by RALPH GRAVLEY and FRANCES GRAVLEY, JACK W. CARLTON and
HAZEL CARLTON, and BARRY J. GWINN, pertaining to three parcels of
land and the maintenance and access to a private street named
"Jesse Court".

The above named parties were conveyed three separate parcels of property by separate deeds dated March 5, 1980, on the eastern side of U. S. Highway 290, in the County of Greenville, State of South Carolina, on a plat entitled "J and S Estates" prepared by Webb Surveying & Mapping Company dated November, 1975, and having according to said plat, in the aggregate, the following metes and bounds:
