in hand paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed and by these presents does grant, bargain, sell and convey unto the said party HER heirs and assigns, all that tract and parcel of land lying and being in GREENVILLE COUNTY, STATE OF SOUTH CAROLINA, BEING KNOWN AND DESIGNATED AS LOT No. 40 AS SHOWN ON A PLAT OF VALENCIA ESTATES by W.N. WILLIS, ENGINEERS DATED Nov. 19, 1960, RECORDED IN THE R.M.C. OFFICE for GREENVILLE COUNTY IN PLAT Book M1 AT PAGE 1M, AND HAVING ACCORDING TO SAID PLAT, THE FOLLOWING DESCRIPTION, TO WIT:

BEGINNING ON BARCELONA STREET AT AN IRON PIN AT joint front CORNERS OF LOTS 41 AND 40 AND RUNNING THENCE 20 FT. WITH THE LINE UP SAID STREET TO AN IRON PIN AT joint FRONT CORNERS OF LOTS 40 AND 39; RUNNING THENCE 160 FT. WITH THE SIDE LINE OF 16FT 39 TO AN IRON PIN AT joint REAR CORNERS OF LOTS 4A, 39, 45, AND 44; RUNNING THENCE 80 FT.
