

Beginning at an iron pin on the eastern side of Butler Avenue, at the corner of John B. Marshall, now or formerly, which iron pin is situate, before the widening of the road by the S. C. Highway Dept., 215 feet, mo or less, from the intersection of West Washington Street, and running thence along the Marshall property S 65-15 B 251.4 feet to an iron pin; thence N 24-30 E 145.2 feet to an iron pin at the corner of Adams and Whitmire, now or formerly: thence N 66 W 33 feet, more or less, to an iron pin; thence with Whitmire, N 22-46 W 200 feet to an iron pin on the southern side of Hampton Avenue; thence with said avenue N 66-30 W 80 feet to an iron pin; thence S 22-46 W 150 feet to an iron pin; thence N 65-15 W 155 feet to an iron pin on the eastern side of Butler Avenue, which iron pin is situate 150 feet from the intersection of Hampton Avenue; thence along the eastern side of Butler Avenue, S 19 W 198.3 feet to the point of beginning.
