GERLINE JACKSON, her heirs and assigns forever:

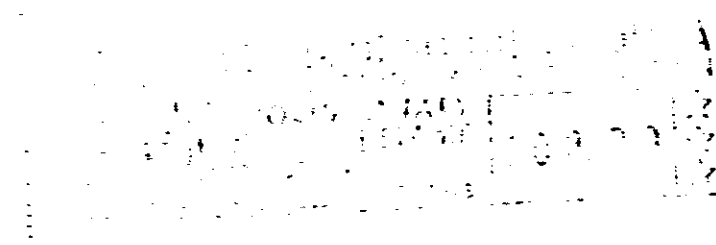
